NOTICE TO BIDDERS

Online and diskette bids will be received until 11:00 A.M., Local Time, on September 10, 2008. Diskette bids will be received by the Contract Management Services Manager for the Pennsylvania Turnpike Commission, at the Administration Building, Ground Address: 700 South Eisenhower Boulevard, Middletown, Pennsylvania 17057 (Mailing Address: P.O. Box 67676, Harrisburg, Pennsylvania 17106-7676). Bids will be publicly opened and read for the following Contract:

CONTRACT NO. 07-027-RCPF-C – COLLISION DAMAGE REPAIRS, BRIDGE NO. B-552 AT MILEPOST 153.06 AND BRIDGE NO. B-518 AT MILEPOST 154.42 IN BEDFORD COUNTY, PENNSYLVANIA.

This Contract provides for collision damage repairs of Bridge No. B-552 at Milepost 153.06 and Bridge No. B-518 at Milepost 154.42. The bridge repair work includes heat straightening the lower flange and web of existing girders, zone painting damaged areas and sections of the existing paint system damaged during heat straightening operations, installation of new structural steel strengthening members, and grinding smooth gouged areas of the lower flange cover plates.

Work items include, but are not limited to:

- LS Maintenance and Protection of Traffic
- LS Structural Steel Repairs
- LS Painting of Existing Structural Steel
- LS Containment
- LS Waste Management
- LS Worker Protection
- LS Heat Straightening Girders

This Project is located on the Pennsylvania Turnpike System at Milepost 153.06 and Milepost 154.42, approximately 7 miles and 8.5 miles east of the Bedford Interchange, Exit No. 146, respectively, in Bedford County, Pennsylvania.

Bowmansville, Milepost 288.3, North Side of Turnpike, Access via Panorama Drive off PA Route 897.

Plymouth Meeting, Milepost 333.6, North Side of Turnpike, Access via Germantown Pike, East on Plymouth Road.

Pocono, Milepost A-94.7, Access via I-80, Exit 273 and PA Route 940 at Pocono Interchange.

An electronic bid bond, from an approved vendor, with corporate surety, in the amount of five (5%) percent of the bid must be submitted with the proposal as bid security. The bid security of the three (3) low bidders will be retained until the execution of the contract. (The normal time for execution of the contract is approximately four [4] weeks.)

A Prequalification Certification and Applicable Capacity Rating assigned by the Prequalification Office of the Pennsylvania Department of Transportation is a necessary prerequisite for bidding on this project.

The opening and listing of bids not meeting all the terms and conditions of the bid advertisement or bid procedures does not act as a waiver or modification of any requirements contained in the bid advertisement or bid procedure.

The Provisions of the Pennsylvania Prevailing Wage Act of August 15, 1961, P.L. 987, as amended, together with the rates and regulations promulgated by the Secretary of Labor and Industry applicable thereto, shall apply to this contract.
