NOTICE TO BIDDERS

Online and compact disk bids will be received until 11:30 AM, Local Time, on June 6, 2012. Compact disk bids will be received by the Contract Management Services Manager for the Pennsylvania Turnpike Commission, at the Administration Building, Ground Address: 700 South Eisenhower Boulevard, Middletown, Pennsylvania 17057 (Mailing Address: P.O. Box 67676, Harrisburg, Pennsylvania 17106-7676). Bids will be publicly opened for the following Contract:

CONTRACT NO. A-070.26F001-3-02 – HEAT DETECTOR INSTALLATION AT THE LEHIGH TUNNEL BETWEEN MILEPOSTS A-070.26 AND A-071.15 IN LEHIGH AND CARBON COUNTIES, PENNSYLVANIA

This project provides for the installation of new fire alarm manual pull stations and a linear heat detection system in the North and South bound tunnels.

Work items include, but are not limited to:

- Linear heat detection system (approximately 12,900 linear feet) at the roof of each roadway tunnel.
- Manual pull stations (approximately 40) on not more than 300 foot spacing along the length of each tunnel and in each cross passageway. All manual pull stations and conduit below the light fixtures located in the tunnel shall be channeled and recessed into the wall.
- Heated junction boxes (approximately 14) for the addressable fire alarm modules including electrical circuits.
- Maintenance and Protection of Traffic

Milepost A-070.26 is located approximately 13 miles north of the Lehigh Valley Interchange, Exit 56, and Milepost A-071.15 is located approximately 5 miles south of the Mahoning Valley Interchange, Exit 74, in Lehigh and Carbon Counties, Pennsylvania.

The proposal and plans are published electronically in EBS and are available to registered business partners for downloading and printing.

An electronic bid bond, from an approved vendor, with corporate surety, in the amount of five (5%) percent of the bid must be submitted with the proposal as bid security. The bid security of the three (3) low bidders will be retained until the execution of the contract. (The normal time for execution of the contract is approximately four [4] weeks.)

A Prequalification Certification and Applicable Capacity Rating assigned by the Prequalification Office of the Pennsylvania Department of Transportation is a necessary prerequisite for bidding on this project.

The opening and listing of bids not meeting all the terms and conditions of the bid advertisement or bid procedures does not act as a waiver or modification of any requirements contained in the bid advertisement or bid procedure.

The Provisions of the Pennsylvania Prevailing Wage Act of August 15, 1961, P.L. 987, as amended, together with the rates and regulations promulgated by the Secretary of Labor and Industry applicable thereto, shall apply to this contract.
