**NOTICE TO BIDDERS**

Online and compact disk bids will be received until 11:00 A.M., local time on August 28, 2013. Compact disk bids will be received by the Contract Management Services Manager for the Pennsylvania Turnpike Commission, at the Administration Building, Ground Address: 700 South Eisenhower Boulevard, Middletown, Pennsylvania 17057 (Mailing Address: P. O. Box 67676, Harrisburg, Pennsylvania 17106-7676). Bids will be publicly opened for the following Contract:

**CONTRACT NO. EN-00148-03-02 - BRIDGE REPAIRS**, between Milepost 000.00, Exit 1 and Milepost 109.91, Exit 110, between Milepost B-014.63 and Milepost B-031.03, between Milepost S-000.00 and Milepost S-005.65, between Milepost M-000.00 and Milepost M-053.00, and between Milepost G-000.00 and Milepost G-013.41 on the Pennsylvania Turnpike System in Lawrence, Beaver, Butler, Allegheny, Westmoreland, Somerset, Fayette, and Washington Counties.

This project provides for the Commission to issue Work Authorizations to the Contractor to perform bridge repairs as the need arises. The contract time period will extend from the date of Notice to Proceed to April 24, 2015.

Major work items may include the following items:

- Maintenance and Protection of Traffic
- Underdeck Protection Shields
- Latex Modified Concrete Deck Patching
- TechCrete Deck Patching Repair
- Class AA Cement Concrete Repairs
- Scour Mitigation

Quantities will not be determined until Work Authorizations are issued. If work is required for which no item has been identified, the Commission will negotiate with the Contractor to provide compensation for the work to be performed.

It is understood that the total maximum value of this contract, to the Commission, may not exceed the amount of Two Million Dollars (\$2,000,000.00).

The proposal is published electronically in EBS and is available to registered business partners for downloading and printing.

An electronic bid bond, from an approved vendor, with corporate surety, in the amount of One Thousand Dollars (\$1,000.00) must be submitted with the proposal as bid security. The bid security of the three (3) low bidders will be retained until the execution of the contract. (The normal time for execution of the contract is approximately four [4] weeks.)

A Prequalification Certification and Applicable Capacity Rating assigned by the Prequalification Office of the Pennsylvania Department of Transportation is a necessary prerequisite for bidding on this project.

The opening and listing of bids not meeting all the terms and conditions of the bid advertisement or bid procedures does not act as a waiver or modification of any requirements contained in the bid advertisement or bid procedure.

The Provisions of the Pennsylvania Prevailing Wage Act of August 15, 1961, P.L. 987, as amended, together with the rates and regulations promulgated by the Secretary of Labor and Industry applicable thereto, shall apply to this contract.
