**NOTICE TO BIDDERS**

Online and compact disk bids will be received until 11:00 A.M., Local Time, on September 17, 2014. Compact disk bids will be received by the Contract Management Services Manager for the Pennsylvania Turnpike Commission, at the Administration Building, Ground Address: 700 South Eisenhower Boulevard, Middletown, Pennsylvania 17057 (Mailing Address: P.O. Box 67676, Harrisburg, Pennsylvania 17106-7676). Bids will be publicly opened for the following Contract:

**CONTRACT NO. EN-00124-03-04 - SINKHOLE REPAIRS BETWEEN MILEPOST 199.26 AND MILEPOST 312.03 IN FRANKLIN, CUMBERLAND, YORK, DAUPHIN, LEBANON, LANCASTER, BERKS AND CHESTER COUNTIES, PENNSYLVANIA**

This contract provides for the Commission to issue Work Authorizations to the Contractor to perform sinkhole repairs as the need arises. The contract time period will extend from the date of Notice to Proceed to November 18, 2016.

Work may include repair of sinkholes, and the repair of shoulders and/or roadway when the sinkhole extends into the shoulder and/or roadway.

Major work items may include the following items:

- Excavation
- Sinkhole Repair by Drilling and Grouting (Compaction Grouting)
- Excavated Sinkhole Repair
- Soil Cement Grout
- Flowable Backfill
- Continuous Soil and Rock Drilling and Sampling
- Biaxial Geogrid
- Pavement Patching

Miscellaneous repairs may include other types of work that are not associated with the items of work being bid. If the need arises for such work, prices to perform the work will be negotiated with the Contractor for each work authorization.

Quantities will be determined with each Work Authorization that is issued.

It is understood that the total maximum costs for this contract, to the Commission, may not exceed the amount of Five Hundred Thousand Dollars (\$500,000.00).

The proposal is published electronically in EBS and is available to registered business partners for downloading and printing.

An electronic bid bond, from an approved vendor, with corporate surety, in the amount of One Thousand Dollars (\$1,000.00) must be submitted with the proposal as bid security. The bid security of the three (3) low bidders will be retained until the execution of the contract. (The normal time for execution of the contract is approximately four [4] weeks.)

A Prequalification Certification and Applicable Capacity Rating assigned by the Prequalification Office of the Pennsylvania Department of Transportation is a necessary prerequisite for bidding on this project.

The opening and listing of bids not meeting all the terms and conditions of the bid advertisement or bid procedures does not act as a waiver or modification of any requirements contained in the bid advertisement or bid procedure.

The Provisions of the Pennsylvania Prevailing Wage Act of August 15, 1961, P.L. 987, as amended, together with the rates and regulations promulgated by the Secretary of Labor and Industry applicable thereto, shall apply to this contract.
